

Facility mentoring and coaching guide









Introduction

Breakthrough ACTION's facility mentorship program is a peer-to-peer, whole-site approach in which peer mentors visit facilities quarterly to actively engage with all healthcare providers to improve the quality of care.

Far from a fault-finding supervisory visit, the program is designed to foster a supportive environment. Mentors are drawn not from supervisory authorities but from peers who can directly relate to the challenges and experiences of current providers. They may serve as officers-in-charge (OICs) for other facilities and are often past schoolmates or teachers from nursing and midwifery schools.

The program covers health areas such as family planning, malaria, and respectful maternity care. During these facility mentoring/coaching visits, mentors and facility providers participate in observations and group discussions, enabling the identification of challenges and the factors contributing to them while emphasizing actionable steps facilities and providers can take.
